



AUCTION OF CAFETERIA

GC University, Lahore invites E-Bids from the Lahore based experienced and reputed firms / bidders / caterers for the auction of two (02) Cafeteria. The name of service points are following:

- The contract may be awarded to successful bidders for maximum period of three (03) years, extended on a yearly basis subject to satisfactory performance.
- All E-Bids must be submitted with Bid Security (Refundable), which should be furnished in the shape of CDR / SDR / Banker's Cheque as mentioned above in favor of Government College University, Lahore. No conditional bank guarantee shall be accepted.
- Single Stage Two Envelope bidding procedure shall be applied.
- The complete E-Bids must be submitted online on e-procurement system (EPADS) website i.e. <http://punjab.eprocure.gov.pk> as per following schedule.
 - E-Bid Closing Date & Time **31/07/2026 Till 10:00am**
 - E-Bid Opening Date & Time **31/07/2026 Till 11:00am.**
- Detailed specifications, tender terms & conditions have been mentioned in the bidding documents.
- Bidding documents can be downloaded from the PPRA website or from EPADS.
- Original Bid Security must be submitted in an envelope clearly marked with the tender Title / Point Names, well before the closing date and time in Office of the Director Purchase, GC, University, Lahore, failing which E-bid shall be considered Non Responsive.
- Firms / Bidders / Caterers are advised to ensure uploading the Bid on E-PADS portal, well before the submission deadline, and not wait for the last date and time to upload the bid.
- Bid submission on E-PADS portal shall entirely be the responsibility of the firms / bidders / caterers, GC University Lahore shall not be held responsible for any issue thereof.
- All the applicable taxes (Direct Taxes, Indirect taxes or any other tax) imposed by the Govt. (Provincial & Federal) during the course of contract shall be paid by the contractor in addition to the bid price/ contract amount.
- GC University Lahore reserves the right to reject/cancel the bids at any time prior to award of contract/acceptance of bid.
- One Firm / Bidder / Caterer may apply / submit bid only for one Cafeteria specifically.
- Any Bid / Price / amount offered by any Firm / bidder / caterer below than reserved / based price shall stand non-responsive / rejection of the Bid.

NOTE:

- Any firms / bidders / caterers which have outstanding(s) dues / amount / tax etc. with GC University Lahore cannot participate in the bidding process until the submission of the clearance certificate issued by the Treasurer / Estate Office GC University Lahore.
